Gary has distinguished himself as a Berrien Springs Regional Director in 2018-19. He has vast administrative experience serving as a principal, superintendent, CEO of the East Detroit Public Schools and a Michigan Account Representative for the Michigan Department of Education.

The Assistant Executive Director's position is a new position as a result of the re-negotiations of the Vendor's Agreement with Berrien Springs. The position allows Gary the ability to provide total focused attention to the performance of Success VLC schools, which I am confident will result in significant performance improvements. In the past, Executive Director Bell was responsible for the 12 Berrien Springs Partnership Schools and our 10 Success Schools. Splitting attention rarely is a recipe for outstanding performance.
